TennCare has selected a group of core quality metrics for the Health Link program. TennCare recognizes that this is not the complete set of measures required for a member to be considered compliant across all HEDIS measures. TennCare encourages Health Links to continue to work closely with the MCOs to identify and close those care opportunities.

The descriptions for HEDIS measures below are based on HEDIS 2020 specifications. Organizations will always be measured on the most recent HEDIS specifications available.

Note: On July 01, 2020 HEDIS® released updated measures for Calendar Year 2020. Please consult the Quality & Efficiency Metrics Appendix Addendum in Section 21 for the updated CY2020 core measures as of August 2020.
