The application cycle will close on April 13, 2020 at 11:59 p.m. ET.

The purpose of the OIFSP is to support training programs in expanding the number of peer support specialists, and other behavioral health-related paraprofessionals, who are trained to work in integrated, interprofessional teams to provide services to children whose parents, and their family members who are in guardianship roles, are impacted by opioid use disorders and other substance use disorders.



Title: New Grant to Train Behavioral Health Paraprofessionals

State-licensed mental health nonprofit and for-profit organizations, including academic institutions such as accredited universities, community colleges and technical schools, across the nation are now eligible to apply for the 2020 Opioid-Impacted Family Support Program (OIFSP) grant, under a funding opportunity announcement released this week by the Health Resources and Services Administration (HRSA) Bureau of Health Workforce (BHW).

As part of HRSA's efforts to combat the nation's opioid crisis, it is imperative to address the needs of everyone affected by opioid and substance use disorders (SUD). HRSA understands the need to train and increase the number of peer support specialists, and other behavioral health-related paraprofessionals, who provide services to children whose parents, and their family members who are in guardianship roles, are impacted by opioid use disorders and other substance use disorders.

The OIFSP grant supports training programs that enhance and expand paraprofessional's knowledge, skills and expertise. Applicants must demonstrate knowledge and understanding of the specific concerns for children, adolescents, and transitional aged youth in high need and high demand areas who are at risk for mental health disorders and SUDs.

The training programs can include behavioral health-related paraprofessional occupations such as peer support specialist, peer support counselor, community health worker, outreach worker, behavioral health aide, social services aide, substance abuse/addictions worker, youth worker, and promotor/a, among other eligible titles.

The expected available funding of \$11,500,000 for FY 2020 will fund an estimated 19 awards. Awarded programs will receive up to \$600,000 per year for a period of 4 years. The application cycle closes on April 13, 2020.



HRSA will host a <u>technical assistance call</u> on February 4, 2020 from 1:00 - 2:30pm ET to provide more details about this grant and the application process, and answer questions from participants.
